**NOTIFICATION**

The 27<sup>th</sup> October, 2017

No.LL-II-FM-11-2015/ 8159/LESI, Whereas the draft of certain rules, further to amend the Odisha Factories Rules 1950, was published as required by section 115 of the Factories Act, 1948 ( 63 of 1948) in the *Odisha Gazette in issue No.30*, dated the 11<sup>th</sup> August, 2017 under the notification of the Government of Odisha in the Labour and ESI Department No.5467, dated the 11<sup>th</sup> July, 2017 inviting objections or suggestions from all persons likely to be affected thereby till the expiry of a period of forty-five days from the date of publication of the said notification in the *Odisha Gazette*;

And, whereas no objection or suggestion is received within the period so stipulated in respect of the said draft;

Now, therefore, in exercise of the powers conferred by section 112 of the said Act, the State Government do hereby make the following rules further to amend the Odisha Factories Rules, 1950, namely:-

1. (1) These rules may be called the Odisha Factories (Amendment) Rules, 2017.  
(2) They shall come into force on the date of their publication in the *Odisha Gazette*.
2. In the Odisha Factories Rules, 1950 (hereinafter referred to as the said rules), in rule 4, after the words "grant of license", the following words shall be inserted, namely:-  
"with an option to apply for one year term or five year term or ten year term licence".
3. In the said rules, in rule 5, after a sub rule (1), the following sub-rule shall be inserted, namely:-  
  
"(1-a) A licence for five year or ten year term shall be granted in Form No. 4A by the Chief Inspector on payment of five times or as the case may be ten times of the licence fee in vogue".
4. In the said rules, after Form 4, the following form shall be inserted, namely:-




